

ALL ABOUT DRIVING, INC.

1. This Contract between ALL ABOUT DRIVING, and \_\_\_\_\_ (student) and \_\_\_\_\_ student's parent(s) covers a course in driver's instruction which may include classroom and/or behind the wheel instruction. All students must have a valid restricted permit signed and be at least 14 years and six months before taking the classroom.
2. ALL ABOUT DRIVING will NOT refund money when actual services have been rendered.
3. ALL ABOUT DRIVING will make all reasonable efforts to complete the contracted instruction for each student within a normal period of time. Delays could result due to vehicle breakdown or personal illness.
4. ALL ABOUT DRIVING cannot and does not guarantee that the student will successfully pass the North Carolina Motor Vehicles Division written or in-car examination upon completion of the course of instruction. ALL ABOUT DRIVING will exert every effort to properly prepare the student to meet the exam requirements.
5. The dates of instruction must be strictly followed. In the event of unforeseen contingencies, the student and ALL ABOUT DRIVING may elect changes to the schedule as needed.
6. A Driving School vehicle may be used for the road test or driving test at a cost of \$\_\_\_\_\_ for each time the vehicle is used in the exam. Arrangements must be made in advance.
7. NO ALCOHOLIC BEVERAGES ARE PERMITTED ON DRIVING SCHOOL PROPERTY, VULGAR LANGUAGE WILL NOT BE ALLOWED. SMOKING WILL NOT BE ALLOWED IN SCHOOL BUILDING, IN VEHICLES, OR ON SCHOOL PROPERTY. MODEST CLOTHING SHOULD BE WORN.
8. STUDENT DISCIPLINE PROBLEMS WILL NOT BE TOLERATED. VIOLATIONS COULD RESULT IN FORFEITURE OF TUITION.
9. Payment of professional services is payable in advance by cash, personal check or money order. If a check is dishonored by the bank, the student's Driver's Education Certificate will not be issued until the check is made good. A \$25.00 returned check fee will apply.
10. Each student taking the driver's Education program will be required to assist ALL ABOUT DRIVING in keeping a time card of instruction credits.
11. This contract covers only the following: ( ) Unlicensed driver (30 hours classroom & 6 hours road work) Cost is \$500.00. ( ) Additional instruction classroom or in-car \$\_\_\_\_\_ per hour, 2 hour minimum. ( ) Adults (18 years or older) \$\_\_\_\_\_ per hour, 2 hour minimum or \$\_\_\_\_\_ for 6 hour class, testing and driving training. ( ) Special need training- individually contracted.
12. Each teen will be given a letter at the end of his training which will inform the parent of concerns his instructors may have or suggestions for the parents. Every teens' parent should request this letter from his teen the last day of class.
